

The 49<sup>th</sup> Annual Fireside Arts & Craft Show will be held February 17<sup>th</sup> and 18th, 2024. Unicoi State Park and Lodge is excited about the show and is certain it will be a tremendous success. As a change to previous years the show will be opened to a larger variety of artistic mediums.

The participation fee is \$125.00 per booth for those who book between now and January 31, 2024. The fee for exhibiting in the show for returning artists that participated in our 2023 show is \$100.00.

All vendors are encouraged to demonstrate their work during the duration of the show. There is no cost for the public.

A special rate is available to all vendors who decide to stay here with us at Unicoi, if you book your room(s) between Now and January 30, 2024 you will receive the rate of \$94.00 per night.

The <u>approximate</u> booth size is 10'X 10'. We will do our best to meet your requests. If you would like a double booth (10'x 20'), then you must purchase two spaces, <u>TWO BOOTH MAXIMUM</u> (10'X 20'). Unicoi will provide tables and chairs upon request (please indicate on your application). We DO NOT provide extension cords, power strips or table cloths. Please indicate if you need electricity on your application, as well as any other special requests (floor preference, near the loading dock, next to a friend's booth, etc.) Please understand we will do our best to meet your request however it is a REQUEST.

Although, it is an indoor show, lighting throughout the building varies and is not always conducive to the needs of the vendors.

We are excited for you to join us and make the 49th Fireside Arts & Crafts Show the best yet.

# The 49<sup>th</sup> Annual Fireside Arts & Crafts Show will be held February 2024

### UNICOI FIRESIDE CRAFT/ART SHOW RULES AND REGULATIONS

In fairness to all artist/crafters that are accepted into the Fireside Craft/Art Show and to insure a quality show for our visitors, we require that all participants comply with the following rules. All show rules will be enforced. Failure to abide by these rules can result in non-acceptance in future years.

- (1) Craft or Art work must be the direct product of artist. Items created from kits will not be considered. Kits or How-To products will not be permitted for sale.
- (2) Only one (1) craft/art category will be allowed per booth.
- (3) Original art must occupy at least 50% of the booth display. The remainder 50% of the booth must also be the direct product of the applicant. Medium not included in the application will not be permitted.
- (4) Applicants taking advantage of the special participant rates MUST pay full booth fee to Unicoi State Park at the time that the application is submitted. Applicants must provide own Booth/Display.

#### \*\*\*\* Booth fee is non-refundable.

- (5) Booths are required to be completely set up and ready to open
  By 10:00 am Saturday, February 17th, 2024. (You may begin set up any time on Friday, February 16<sup>th</sup>)
- (6) Booths must remain set up until 4:00 pm, Sunday, February 18, 2024.

  There must be enough products to sell through the entire show.
- (7) Application forms must be signed to be considered.
- (8) Artists/Crafters need to remain with their booths from open to close each day of the show, with the exception of breaks, and/or emergencies.
- (9) Artists must keep exhibits inside the parameter of their booth space, anyone outside the allotted space will be asked to adjust their exhibit.
- (10) No canopy tops will be allowed, <u>frames only!</u> Artists cannot block the view of other fellow vendors, please be courteous to your booth neighbor.
- (11) Please include photos of your booth set up with your application.
